

**Do you have:** cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, feeling feverish or a measured temperature greater than or equal to 100.0 degrees Fahrenheit and/or have had known close contact with a person who is lab confirmed to have COVID-19? **If you answered yes to any of these questions, then please refrain from visiting us.**

**The mini-golf course** requires the walking of stairs and involves walking on uneven surfaces. Masks will decrease one's visual field thus greatly increasing the risk for fall/injury. As such, wearing a face mask while on our mini-golf course is not recommended. As our mini-golf-course is open air, that also diminishes the need for masks as the course receives ample air exchange. If you do opt to wear a mask while on the golf course and are found to be exhibiting behavior endangering yourself or others, you will be asked to leave the golf course. Customers can't exceed more than two 4 player golfer groups per island (all 4 coming from the same household). We also ask that adequate space is given between players and groups. Sanitizing wipes will be provided for balls, clubs and pencils. We also ask that you refrain from using the water fountain unless you have your own sanitizing wipes or hand sanitizer.

**The go-karts** require operation of a mechanical device and the mental and physical abilities to do so. Masks will decrease your visual field and the increase in CO2 inhalation will decrease the ability to react quickly, thus increasing the risk for impact and injury. We ask that masks not be worn while in the go-karts. Masks while driving/riding the go-karts also risk coming off and becoming debris as well as suffocation hazards while driving/riding. If you are not comfortable with not wearing a mask while driving/riding the go-karts, then please refrain from doing so. Also remember that our track, pit lanes and queues are all outdoors, thus allowing for excellent air exchange. For the time being we will reduce our number of queues from four to two to provide more spacing between customers. We ask that within each group, people group no more than four per group (of the same household) and that groups distance themselves at least 6 ft apart while in the queues. We will load four people (of the same household) maximum at a time into the karts. Once the go-karts are full, then we will release the karts. At the end of the ride we will allow four karts to enter the pit lane and unload at a time until all karts are unloaded. At that point the process will repeat. We will be disinfecting go-karts, boosters, seat belt extenders between rides. As previously stated, hand sanitizer will be available outdoors for both pre and post-riding/driving hand sanitizing. Hand sanitizer will also be available at our counter (as always).

**Regarding hands:** Hand sanitizer will also be available at our counter and outdoors. Our restrooms are also stocked with hand soap (as always). There is one additional hand sanitizer station by the downstairs restrooms. If there is a need to cough/sneeze, as it is allergy season, then please do so into your elbows, tissue, etc. Do not cough/sneeze into your hands or into the air. Please avoid touching your face with unwashed/unsanitized hands.

Our go-kart attendants will have to run, climb, yell safety directions and use whistles. Masks will impede the ability of our attendants to carry out their ASTM required safety duties and will interfere with workflow. In lieu of masks we are asking that any/all attendants abide by the same health self-screen protocol as our customers. We will be taking the temperature of our attendants as an extra precautionary measure. If an employee becomes sick during the day, they will be sent home immediately.

Until Phase 2 of OpenTexas "kicks in", our laser tag arena and gameroom will remain closed to the public as those attractions are hands on.

#### **AS A REMINDER:**

Per ASTM F2007-18

7.17.1: There are inherent risks in the participation in or on any amusement ride, device, or attraction. Patrons of an amusement ride, device, or attraction by participation, accept the risks inherent in such participation of which the ordinary prudent person is or should be aware. Patrons have a duty to exercise good judgment and act in a responsible manner while using the amusement ride, device, or attraction and to obey all oral or written warnings, or both, prior to or during participation, or both.

7.17.2: Patrons have a duty not to participate in or on any amusement ride, device, or attraction when under the influence of drugs or alcohol.

7.17.3: Patrons have a duty to properly use all ride or device safety equipment provided.
